### 2. NSA CHAIR'S UPDATES

### **INFORMATION**

Chair Gabrielle Clark will give updates on the NSA goals for the year as well as brief the Alliance membership of informal group meetings she has participated in with various Nevada legislators.

Chair Clark gave updates as to her activities since the last NSA Meeting. She attended a meeting with Speaker Frierson, faculty senate and chancellor Rose. They discussed what is going on with the legislature and Frierson's views on the next session and any proposed or additional cuts. He suggests that NSHE keep an open mind as to creative solutions as there will be cuts across the state, not just NSHE. There was talk about NSHE collaborating with k-12 education and a support system with one another for the legislative session.

As for NSA goals this should be a shared effort among all NSA and lobby for higher education students in legislation this year. As well as having our goals be in tandem with Chancellor Rose – like community college and university relationships and transfer being universal.

## 3. MEMBER REPORTS

### **INFORMATION**

NSA members will each be invited to provide an update on current and planned events, initiatives and other activities or actions taking place on their campuses and within their student government organizations.

Will Carrasco – held a successful Graduate Town Hall recently and is focusing on closing down the semester.

Katie Dempsey – student government donated \$100,000 to the Winemucca student building and trying to keep students involved while virtual.

Alyssa Fromelius – working on video to discouraging student cheating in collaboration with tutoring cener, approved a project to integrate door openers with foot to reduce touch points, student town hall coming up regarding SU grading and covid procedures with the President of TMCC. Screening a movie regarding disparities native American students faced in the past.

Dominique: just approved the budget amendments ASUN sent in for more scholarships and internships, continuing to highlight diverse student on campus, and then student senate to remove campaign deposit for elections so students do not have that barrier.

Matthew Varre – will have a virtual commencement for UNLV students, had a student researcher award program to help grad students, cap and gown program to help take pictures for commencement. They also have student and faculty awards that are accepting nominations.

Joshua Padilla - spoke of a student and faculty town hall regarding SU, COVID operations update for next semester, financial aid questions.

Suman Randhawa— town hall, mentioned U/S grading passed for the next year for students. Has two new student senators coming in. Giving recommendations for the NSC presidential search advisory committee. Scholarship taskforce to discuss what scholarships to be funding.

Discussion of potential name change of Nevada State College to Nevada State University and asked NSA members for support.

The body will discuss feedback gathered from their respective institutions and any additions or modifications to the draft resolution that may be approved and sent to the Board of Regents and NSHE Officers.

Motion: Will Carrasco motion to approve the resolution

2<sup>nd</sup>: Suman Randhawa

Discussion: Dominque took it back to her cabinet and they support it. They hope it is a foot in the door to other recognized religious holidays. Suman brought it to NSSA and it was supported. Will took it to GSA and there was a concern to limiting it to Jewish holidays but discussed it as a 'foot in the door'. Alyssa took it to her campus – the question was whether it was to get the dates off or just recognized? Dom clarified to recognize to let them have off. Also – is the resolution to just have the two holidays? Dominque is not sure as her Hillel of Northern Nevada group only recommended the two. Suman – wants to know if there were diversity and inclusion in religious practice implemented by NSHE. Dominique said that currently it is up to the professors to accommodate. Suman thinks it should be in policy and procedure.

Gabby - we can set a meeting with Chancellor Rose to clarify. Mathew - it has not been brought up in their council meeting, it will be next week.

# 6. DISCUSSION AND APPROVAL OF NSA RESOLUTION SUPPORTING ELECTION DAY AS A STATE HOLIDAY

**FOR POSSIBLE ACTION** 

Chair Gabrielle Clark will lead a discussion and review of a proposed resolution in support of Election Day being designated a State holiday in Nevada. The body will discuss feedback gathered from their respective institutions and any additions or modifications to the draft resolution that may be approved and sent to the Board of Regents and NSHE Officers.

Joshua Padilla summarized the resolution proposing election day as a state holiday and emphasized Nevada System of Higher Education encompasses a very big voter base in general that can vote on election day and that other states across the nation already doing this.

Alyssa asked if this resolution was a request to get the day off or just to be recognized: Josh- it was to designate as a state holiday in Nevada to give them the day off.

Mathew – we will be discussing on Monday with his council. Although he agrees to support students to vote more and feels the council will vote for it.

Motion: Will Carrasco: Motion to pass the resolution

Second: Joshua Padilla Discussion: None.

Vote: Passes 7-0, 1 abstention.
